PRICES (AMENDMENT) ORDER (No.11) OF (2022)

In exercise of the powers conferred by Section 3(1) and (5) of the Prices Ordinance (Cap 75), I hereby make the following Order:

Short Title:

- 1) This order may be cited as the Prices (Amendment) Order (No.11) of 2022

Commencement:

- 2) This Order shall be deemed to come into operation on the, 2022.

Sale of commodities upon payment of the prescribed price:

- 3) Wholesalers and retailers having commodities available shall not, except with reasonable cause, the onus of proving which shall be upon such wholesaler and retailer, refuse to sell them as stipulated by this order to any person tendering immediate payment at the price not exceeding the prices.
